Subject - Appointments of Representatives to Outside Bodies

Agenda Item: 29

Recommendation: It be RESOLVED: That:

 appointments be made to the outside bodies attached at Appendices 1 and 2 for a term of one year except where stated otherwise, and attendance be designated as an approved duty;

- 2) it be noted that appointments are no longer required for the Rye Chamber of Commerce, the Bexhill Youth Council Adult Support Group and East Sussex County Council's Children's Services Scrutiny Committee (in 2020), and that these organisations be removed from the list;
- 3) Members be reminded of the need to report annually via the Members' Bulletin on the outside bodies to which they are appointed; and
- 4) all other minor amendments / changes to names of organisations be noted.

Introduction

- 1. Full Council has retained the responsibility for approving the list of outside bodies to which formal appointments are made, making such appointments at the Annual Council meeting or as otherwise required.
- 2. Attached at Appendix 1 is a list of the outside bodies which require an appointment to be made by the Council at this meeting. It also shows the name(s) of the current representatives that were appointed for the last municipal year.
- 3. There are a number of appointments which are reserved for Members holding a certain position within the Council, for example the Portfolio Holder for Housing will be the Council's representative on the Sussex Local General Panel (formerly known as the AmicusHorizon Area Panel). Those that are reserved in this way are listed at Appendix 2; these appointments are therefore not open for re-appointment and/or nomination but will be dealt with automatically, following confirmation of appointments. Substitutes, where appropriate, will be confirmed by the Leader of the Council.
- 4. Attached at Appendix 3 is a list of the outside bodies that do not require an appointment to be made this year.
- 5. In considering each appointment, Members will need to take account of the following:
 - the benefit to the authority that continued membership provides; and
 - the views of the previous Member representative, if available.

- 6. To aid the Council's deliberations, Member representatives have been asked to submit comments in support or otherwise of the outside bodies to which they were previously appointed; these comments are attached at Appendix 4 for consideration. Any comments received subsequent to the publication of this report will be circulated at the meeting.
- 7. Where the Council has appointed non-Councillors as its representatives to certain outside bodies, it is confirmed that all but one non-Councillor representatives are happy to continue to represent the Council in their appointments if that is Members' decision. One of the Council's appointed representatives to the Combe Valley Community Interest Company, Angharad Davies has resigned from the Board of Directors and is stepping down as the Council's representative from this May.
- 8. Members are requested to consider each outside body and appoint thereto. In the light of any evidence given by the previous representative, either on the night or in writing, the Council may also wish to agree to the removal of any outside body from the current list.

Removals from the List

- 9. Since appointments to outside bodies were made in May 2017, there has been one removal from the list in respect of Rye Chamber of Commerce that no longer requires an appointment. This was reported to full Council in July 2017.
- 10. From Councillor Hollidge's report at Appendix 4, it is clear that the Bexhill Youth Council Adult Support Group currently does not exist. It is therefore recommended that no appointment is made and this outside body is removed from the list. Should the Group be resurrected, it can then be reconsidered by the Council.

Children's Services Scrutiny Committee

- 11. Following a review of the scrutiny function at East Sussex County Council, the Children's Services Scrutiny Committee no longer exists and there is no provision to continue with the arrangement for the co-option of the single district/borough representative. The history of that particular arrangement dates back to 2006 following the Children Act, when it was felt that co-opting representatives from key partners (districts/boroughs, health and police) would facilitate a more joined up approach to the safeguarding aspect of the committee's work.
- 12. The district/borough co-optee position has rotated between the five authorities with each appointment lasting two years. This Council was next to nominate in 2020 however this will not now be required and this body will therefore be removed from the list.

Additions to the List

13. Since appointments to outside bodies were made in May 2017, there have been no additions to the Council's list of approved outside bodies.

Reports on Outside Bodies

- 14. It has previously been agreed that Members appointed to outside bodies are required to produce an annual report (published in the Members' Bulletin) to keep all other Councillors informed of the work of the outside body or bodies to which they had been appointed. Appendix 5 lists the reports that have been received from the Council's representatives over the last municipal year. While it is noted only a few reports have been received from the appointed representatives during the last year, it is acknowledged that in some cases this is due to the fact that the outside body has not met or the Council's representative has been unable to attend any meetings.
- 15. A template for reports and timetable will be circulated after the meeting to those Members who represent the Council on outside bodies for reports to be submitted for inclusion in the Members' Bulletin.

Action in Rural Sussex (AiRS): Councillor Ganly

The three operational aims of AiRS are:

- 1. to reduce the incidence and impact of disadvantage and poverty on people living in rural areas;
- 2. to increase the capacity of rural communities to manage change for the benefit of all their members; and
- 3. to inform and amplify the voice of rural communities to influence public policy.

RDC participates in the recently created Sussex Community Housing Hub and will contribute £100.000 over four years. AiRS, which already supports a number of Community Land Trusts in Sussex, including one in Rother, has been commissioned to run the Hub.

The Chief Executive, Jeremy Leggett, has announced his retirement after 29 years and we await details of his successor.

Since my appointment to AiRS, only one meeting has been held, which I attended.

Battle Area Sports Centre Management Committee: Councillor Ganly

RDC contributes £6,000 p.a. towards the cost of upkeep and repairs and will continue to do so until March 2023. The Committee is fully briefed by Claverham staff at the A.G.M.

Bexhill Trust: Councillor Mrs Potts

I am very happy to continue with their charitable monetary help in Bexhill.

Bexhill Youth Council: Councillor Hollidge

Main concerns:

- 1) The Bexhill Youth Council does not exist due to lack of members and no committee.
- 2) We do not, as I understand it provide any money or administration.

However, a new structure is being created and a request has been made for the +/-£800 in the account to be transferred over.

De La Warr Pavilion: Councillor Mrs Hart

A vital asset for Rother and I have attended necessary meetings.

East Sussex Waste Portfolio Holders Group: Councillor Ganly

It is several years ago that I attended a meeting of this group which appears to have ceased.

Hastings Furniture Service: Councillor Watson

Fully supportive of the Hastings Furniture Service; it provides good value to Rother.

LGA Coastal Issues Group: Councillor Jenkins

It is important that as a coastal authority we are represented as are the many covering the whole country. The Executive are well aware of the actions of the group who have direct links with Government Ministers on the subject of the environment.

This last year we had the tragic case relating to Camber, which was presented to the group by Brenda Mason. This was beneficial for other authorities to hear about, not least to learn lessons from, which would be valuable in their own planning.

Romney Marsh Partnership: Councillor Hart

The Partnership is undertaking some good initiatives and it is worth RDC staying involved with a formal appointment. I would also like to remain RDC's representative as we have achieved quite a bit in the last 3 years, in particular. The relationship between Rother, Shepway and Ashford is mutually beneficial.

Rother Rural Trust: Councillor Ganly

The Trust was set up in 1998, funded initially by proceeds of the then RDC Chairman's fund-raising (David Amies) and, subsequently, by legacies and donations from Parish Councils. No financial contribution from RDC. The scope is rural Rother i.e. Rother minus Bexhill, Battle and Rye and its objects are wide:

- 1. "for the relief of poverty;
- 2. the advancement of education; and
- 3. any other charitable object for the benefit of the community of rural Rother."

The trustees are six RDC councillors (re-)appointed every year, one County Councillor and one Parish Councillor. The Trust meets twice a year for discussion on grants and other activities, but has an email procedure for urgent decision making. There is no formal application form; applications are by letter to the Clerk. Grants have ranged from £45 to £500. The types of grants given in the past have been for:

- 1. contribution to course fees at Plumpton College;
- 2. cooker, carpeting, washing machine, mattress for needy individuals;
- 3. help to buy sports equipment or obtain sports club training; and
- 4. help for organisations such as Guides, Youth Forum, Disability Forum, School (after school activities), and Village Hall.

Rother Voluntary Action: Councillor Mrs Potts

I am very happy to continue.

Tourism South East (TSE): Councillor Hart

I have not been invited to attend any meetings this year, but as RDC will be reviewing tourism in the near future, it will be necessary to liaise with TSE.
