





- Note 1 Within 28 days of election or appointment to office, a Member of Rother District Council or of any of the Parish/Town Councils in Rother District must register details of his or her personal interests by providing written notification to the Monitoring Officer, Rother District Council, Town Hall, Bexhill-on-Sea, East Sussex, TN39 3JX.
- **Note 2** Within 28 days of becoming aware of any new personal interest or change to any registered personal interest, details of the new personal interest or change must be registered by providing written notification to the Monitoring Officer as above.
